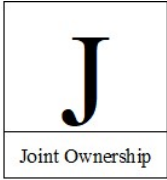

### APPLICATION FOR THE REGISTRATION OF OWNERSHIP OF A PONY IN TWO OR MORE MEMBERSHIP NAMES

#### Conditions:

For the Society to recognise ownership of ponies in two or more membership names:

1. All parties must be full financial members in their own right.
2. All parties must enter into a written agreement nominating a *signatory* or *signatories* to regulate and operate this joint registration. A copy of such must be forwarded to the office.
3. An application fee of **\$20.00** is to be paid.
4. A transfer fee of **\$25.00** is to be paid for each pony attached to the joint ownership / co-ownership.
5. Applications will NOT be accepted unless accompanied by the appropriate fee/s.
6. Method of ownership is to be stated as either JOINT OWNERSHIP or CO-OWNERSHIP. Please tick the method of ownership required.
  - Joint Ownership – if persons are joint owners then their share in the animal ceases entirely on their death, so that ultimately the surviving owner owns the animal outright.
  - Co-Ownership – If persons are co-owners then each co-owner is able to separately deal with their share and that share is not lost on death of the co-owner, but that share forms a part of the co-owners estate to be dealt with according to his or her will. A percentage of co-ownership must be completed, below. If the percentage is left blank, then the application will be construed as approval by the Society to facilitate Joint Ownership.

#### Breeding Options:

1. When registering progeny to the Joint Ownership / Co-ownership, only the above prefixes of owners may be used; or
2. A separate prefix and brand may be applied for. This must be done on a Prefix and Brand Application form, available from the Society website, and carry the signature of all parties to the Joint Ownership / Co-ownership.

#### Signatories to registrations:

1. The signature of ALL co-owners/joint owners must appear on the registration form for ponies first registered recording the breeder as the Joint Ownership / Co-ownership. This indicates agreement between parties that the progeny may be registered with the prefix and brand noted on the registration application form – whether it be an individual's or the brand and prefix belonging to the joint arrangement.

\*\*Please note: should there be more than two people involved in the Joint arrangement, another copy of this form must be attached, recording the details noted above.
