## RECORDING OF LEASE

**The cost of a lease is \$30.** Notification must be received within 60 days of the commencement of the lease. If the notification is received between 43 and 90 days, the fee is \$40 and if it is greater than 90 days the fee is \$60. Regulations for the recording of a lease of a pony state that the lessee must be a financial member of the Society in order for the lease to be recorded. In order for the lessee to register progeny a lease must be activated as per the regulations.
