Animal names are limited to 30 characters including Prefix and spaces.

Only FULL financial members may apply for a Prefix/Brand. It is strongly recommended that members read the Regulations for Entry of Stock before applying for a prefix/brand or sending in a registration for an animal.

The Committee of Management has the right to decline any prefix or brand that are deemed unsuitable. It is the responsibility of the applicant to ensure that the prefix applied for does not infringe upon an existing business or trademarked name. A prefix and brand once registered with the WPCS of Australia Inc. will remain together.

Note: Either fire or freeze branding is accepted by the Society.

Welsh ponies born after 1st August 2013 can be solely microchipped and no longer require branding. Part Welsh are entitled to be microchipped regardless of date of birth.

A prefix may be made inactive after 10 years and offered to another party providing no ponies have been recorded with that prefix.
