**Qualifying criteria for consideration:**

- **You must have been a Tier 2 Welsh judge of the WPCS of A Inc for a minimum of 5 years** or be a Silver/Gold medal approved judge with the WPCS (UK) in order to be appointed to the Tier 1 Welsh In-Hand panel.
- You must have been a member of the WPCS of A Inc or an approved overseas Welsh Society for a minimum of 5 consecutive years and be the nominee of that membership.  
Membership must be a Full Membership unless the applicant is associated with a Full membership in which case being the nominee of a separate Associate membership is accepted.

- **You must have bred at least five animals from the Welsh breed sections**, excluding Part Welsh in order to be appointed to the Welsh In-Hand panel. This does not apply for appointment to the Part Welsh, Ridden or Harness panels. It must be remembered that as a Stud Book society it is paramount that judges are able to assess breeding stock.
- You must be able to declare that you have never had any conviction relating to animal cruelty or child abuse.
- **You must have attended a WPCS of A judges' seminar within the previous 2 years.**
- **You must have judged a minimum 5 WPCS of A shows which must include judging 3 medal shows in the discipline to be applied for** with details of the events and show organiser contact details supplied on the application form. with favourable reports received by COM.
- If you are a National panel judge for performance with an approved Society you will be eligible for inclusion as a Tier 1 judge for that discipline.
